The context

The pandemic has exposed the **scale of global inequalities** and is likely to exacerbate them.

Four in five people in the OECD feel income disparities are too large in their country. People care about inequality of both outcomes and opportunities.

Declining trust in institutions, governments, business & media. In 2019, only 45% of citizens trusted their governments (OECD).

Civic space is declining year by year (Civicus).

As more and more people feel unrepresented by their political systems, **social unrest and populism** is growing.

The challenge

Growing inequality and rising distrust **undermines the transition** to a climate-resilient and sustainable economic system.

Most organisations working on green policy, decarbonisation and environmental protection know they must address inequality.

Equally, inequality campaigners are beginning to recognise that **inclusive green economies** can tackle systemic inequality.

The transition to a green and fair economies require **deep social support**. This is not merely a 'nice to have', it is key if we are to achieve a just transition.





The opportunity



A political space for tackling inequality has opened up:

- Diverse and unusual champions are calling for a 'new social contract', including labour movements, youth movements, UN bodies, and the World Economic Forum.
- As a result of COVID-19, public discourse is increasingly attuned to the connections between human health & wellbeing and planetary health.
- Citizen's visions, priorities and demands are being sought in order to accelerate the green transition and recovery (e.g. Citizen Assemblies; public dialogues; multi-stakeholder consultations)
- People are holding their governments to account. Globally, the cumulative number of climate change-related cases - climate litigation, has more than doubled since 2015 (LSE).



What is a social contract? Execution of the contract of the co

Agreements between citizens and government about the mutual rights and responsibilities that will uphold a just social order. Increasingly, there is the recognition that a social contract must address the relationship between humans and nature, and spur the transformation of economies and societies to halt climate change and environmental destruction.




Convention French Citizens Assembly
